ORDER

On January 10, 2011, Overland Development, Inc. ("Overland") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Overland purchases water from the Big Sandy Water District ("Big Sandy").
2. Big Sandy notified Overland that, effective January 1, 2011, its volumetric wholesale rate to Overland would decrease from \$1.83 per 1,000 gallons to \$1.78 per 1,000 gallons.
3. Overland proposed a purchased water adjustment factor of (\$0.05) per 1,000 gallons.
4. During the 12 months ending November 30, 2010, Overland purchased 7,008,235 gallons of water from Big Sandy and it sold 5,957,000 gallons. The decrease in the cost of purchased water is \$350.41, resulting in a purchased water adjustment factor of (\$0.05) per 1,000 gallons.

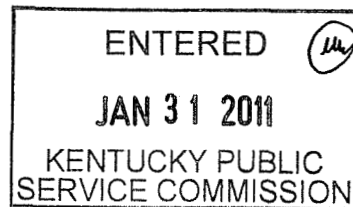

5. The purchased water adjustment factor of (\$0.05) per 1,000 gallons is fair, just, and reasonable and should be approved.

IT IS THEREFORE ORDERED that:

1. The rates proposed by Overland are approved.
2. The purchased water adjustment factor of (\$0.05) per 1,000 gallons, as calculated in Appendix A, is approved.
3. The rates in Appendix B, attached hereto and incorporated herein are fair, just, and reasonable and are approved for services on or after January 1, 2011.
4. Overland's proposed tariff sheet filed with the application, showing the rates approved herein, is approved.
