O R D E R

On February 15, 2011, Caldwell County Water District (“Caldwell County”) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Caldwell County purchases water from the city of Princeton (“Princeton”).
2. Princeton notified Caldwell County, effective January 1, 2011, that Princeton’s wholesale water rate to Caldwell County would increase from \$2.37 per 1,000 gallons to \$2.71 per 1,000 gallons.
3. On January 25, 2011, Caldwell County’s Board of Commissioners voted to place the proposed rates into effect immediately.
4. During the 12 months ending November 30, 2010, Caldwell County purchased a total of 103,704,116 gallons of water from Princeton and sold 77,716,727

gallons. The increase in the cost of purchased water is \$35,259.40 resulting in a purchased water adjustment of \$0.45 per 1,000 gallons.

5. The purchased water adjustment of \$0.45 per 1,000 gallons is fair, just, and reasonable and should be approved.

6. Caldwell County's rates, which are set forth in Appendix B, are fair, just, and reasonable and should be approved for water service rendered on or after January 25, 2011.

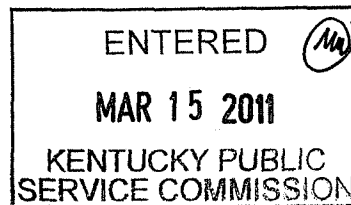
IT IS THEREFORE ORDERED that:

1. The purchased water adjustment of \$0.45 per 1,000 gallons as calculated in Appendix A is approved.

2. The rates in Appendix B are approved for water service rendered on or after January 25, 2011.

3. The tariff sheets filed by Caldwell County are approved as filed.
