## MOTION FOR EXTENSION OF TIME TO COMPLY WITH SCHEDULE IN COMMISSION'S ORDER ENTERED MARCH 13, 2013

Comes Clark Energy Cooperative, Inc. ("Clark"), by and through counsel, and moves the Commission for an extension of time for both parties to comply with the procedural schedule outlined in the Commission's Order entered herein on March 13, 2013 ("the March Order").

In support of Clark's Motion, counsel for Clark states that renewed settlement negotiations remain ongoing between the parties. In recent weeks, the Defendant has made an offer to the Complainant, the Complainant has made a counteroffer to the Defendant, and the Defendant has made a counteroffer to the Complainant. Because both the Complainant and the Defendant are, or are governed by, a board of directors meeting regularly only once a month; because of the difficulties inherent in calling multiple special meetings of said boards (the Defendant's board of

directors being made up of nine individuals from five different counties); and because the Complainant's next regular meeting (at which meeting its counsel has indicated it would like to consider Clark's most recent counteroffer) is not being held until April 18, 2013, the day after which the Complainant's verified testimony is due pursuant to the March Order, Clark believes the Commission should allow the settlement negotiations to proceed and should grant both parties at least thirty (30) days from the dates set forth in the March Order by which to file either testimony or a proposed Agreed Order of Settlement if a settlement is reached.

WHEREFORE, Clark respectfully requests that both parties be relieved from the procedural schedule in the March Order for at least thirty (30) days so that settlement negotiations may proceed.
