INITIAL DATA REQUEST OF COMMISSION STAFF  
TO COLUMBIA GAS OF KENTUCKY, INC.

Columbia Gas of Kentucky, Inc. ("Columbia"), pursuant to 807 KAR 5:001, is to file with the Commission the original and 10 copies of the following information, with a copy to all parties of record. The information requested herein is due no later than April 15, 2011. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.


Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Columbia shall make timely amendment to any prior response if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any request to which Columbia fails or refuses to furnish all or part of the requested information,

Columbia shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

1. Refer to Columbia's application, AMRP Form 1.0.
  - a. Provide calculations producing the billing determinants for each of the Rate Schedules shown in the column labeled "Billing Determinant # of Bills."
  - b. Explain the basis for the customer losses Columbia is projecting through May 31, 2012.
2. Refer to Line 1, Column 6, on AMRP Form 2.0.
  - a. Provide a breakdown of the 2010 additions to Account 376.25, Mains-AMRP, showing the length of pipe for each size of pipe installed.
  - b. For each size of pipe installed, as identified in the response to part a. of this request, provide a breakdown of the installed cost showing separately the cost of materials, the cost of labor, and any other non-materials items.
3. Refer to Line 3, Column 6, on AMRP Form 2.0. Provide details of the 2010 additions to Account 380.25, Service Lines, including number of lines and associated costs.
4. Identify generally the locations of the major main replacements that occurred in 2010 and describe how those specific projects were selected and prioritized.
