APPLICATION

1. Pursuant to KRS 278.2213(13), and all other applicable law, Atmos Energy Corporation (“Applicant” or “Atmos” or “Company”), files its Application herein for an order approving the use of the disclaimer attached hereto as Exhibit “A” when the Company’s name, trademark, brand or logo is used by a non-regulated affiliate of the Company within the Commonwealth of Kentucky.


