**Atmos Energy Holdings, Inc. (AEH)** – AEH is the holding company for Atmos Energy Corporation’s non-regulated subsidiaries. AEH uses the word “Atmos” as part of its logo. AEH does not maintain a presence separate from its subsidiaries. AEH does not offer any services to the public, except through its subsidiaries.

**Atmos Energy Marketing, LLC (AEM)** – AEM provides services to industrial, commercial and municipal customers. AEM uses the word “Atmos” as part of its logo. The logo is used in the ordinary course of business on letterhead, business cards, and other printed materials. AEM does not engage in radio or televised advertisement.

There are two AEM offices in the Commonwealth of Kentucky – one in Owensboro and one in Louisville.

**Atmos Pipeline & Storage (APS)** – APS provides gas pipeline and storage services through Atmos Gathering Company and WKG Storage. APS uses the word “Atmos” as part of its logo. The logo is used in the ordinary course of business on letterhead.

**Atmos Gathering Company, LLC (AGC)** – AGC provides services to small and medium sized gas producers. AGC includes the word “Atmos” as part of its logo.

The logo is used in the ordinary course of business on letterhead, uniforms, and vehicles.

Vehicles -- AGC has 5 trucks and 1 dump truck bearing the AGC logo on one or both doors.

Uniforms -- AGC employees wear uniforms bearing either the Atmos Energy or AGC logo.
