RESPONSE:

 (a) Atmos Gathering Company, LLC (AGC) was formed May 25, 2006.
Atmos Energy Holdings, Inc. (AEH) was formed February 10, 2000.
Atmos Pipeline & Storage, LLC (APS) and Atmos Energy Marketing, LLC (AEM) were formed April 29, 1999.

In 2003, AEM was merged into Woodward Marketing, LLC, which had been in existence since January 23, 1995. The name of Woodward was changed to AEM at the time of the merger.

- (b) The dates requested are not readily available. Atmos is working to provide accurate responses to this request. Atmos is researching files and interviewing company employees to ascertain, as precisely as possible, the dates these entities first operated in Kentucky. The company will supplement its response as soon as the dates are determined A separate Request for Additional Time to Supplement Responses is being filed by Atmos.
- (c) AEH and APS do not maintain a website.
