ORDER

On March 24, 2011, Judy Water Association (“Judy”) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Judy purchases water from the city of North Middletown (“North Middletown”) and the city of Mount Sterling (“Mount Sterling”).
2. Mount Sterling notified Judy that, effective May 1, 2011, its volumetric wholesale rate to Judy would increase from \$2.07 per 1,000 gallons to \$2.34 per 1,000 gallons.
3. Judy proposed a purchased water adjustment factor of \$0.22 per 1,000 gallons.
4. During the 12 months ending February 28, 2011, Judy purchased 43,344,000 gallons of water from North Middletown, and 114,342,000 gallons from Mount Sterling and sold 142,345,060 gallons. The increase in the cost of purchased water is \$30,872.34, resulting in a purchased water adjustment factor of \$0.22 per 1,000 gallons.

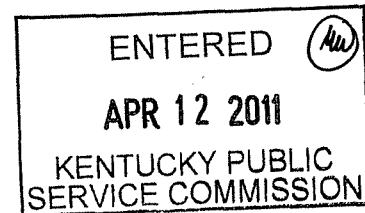

5. The purchased water adjustment factor of \$0.22 per 1,000 gallons is fair, just, and reasonable and should be approved.


IT IS THEREFORE ORDERED that:

1. The rates proposed by Judy are approved.
2. The purchased water adjustment factor of \$0.22 per 1,000 gallons as calculated in Appendix A is approved.
3. The rates in Appendix B are approved for services rendered on or after May 1, 2011.
4. Judy's proposed tariff sheet is approved.
