O R D E R

On April 1, 2011, Farmdale Water District ("Farmdale") applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. Farmdale purchases water from Frankfort Electric and Water Plant Board ("Frankfort").

2. On March 16, 2011, the Commission approved an increase in Frankfort's wholesale water rate to Farmdale from \$1.704 per 1,000 gallons to \$1.81 per 1,000 gallons, effective April 1, 2011.²

3. On April 1, 2011, Farmdale's Board of Commissioners enacted a resolution to increase Farmdale's water rates commensurate with Frankfort's increase effective April 1, 2011.

4. During the 12 months ending December 31, 2010, Farmdale purchased a total of 223,188,000 gallons of water from Frankfort and sold 171,317,000 gallons. The

increase in the cost of purchased water is \$23,657.93 resulting in a purchased water adjustment of \$0.14 per 1,000 gallons.

5. Farmdale's proposed rates should be approved.

6. The purchased water adjustment of \$0.14 per 1,000 gallons is fair, just, and reasonable and should be approved.

7. The rates in Appendix B are fair, just, and reasonable and should be approved for service rendered on or after April 1, 2011.

IT IS THEREFORE ORDERED that:

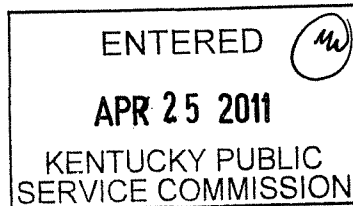
1. Farmdale's proposed rates are approved.

2. The purchased water adjustment of \$0.14 per 1,000 gallons as calculated in Appendix A is approved.


3. The rates in Appendix B are approved for service rendered on or after April 1, 2011.
