O R D E R

On May 16, 2011, Duke Energy Corporation, Cinergy Corp., Duke Energy Ohio, Inc., Duke Energy Kentucky, Inc., Diamond Acquisition Corporation, and Progress Energy, Inc. ("Joint Applicants") filed a letter, which the Commission will treat as a motion, requesting the scheduling of an informal conference and a modification to two dates in the existing procedural schedule. The request for an informal conference has already been granted by the Staff Notice issued on May 17, 2011.

With respect to modifying the procedural schedule, the Joint Applicants seek an extension of two business days for the filing of supplemental data requests and a similar extension for filing responses thereto. The motion also stated that the only intervenor in this case, the Office of the Attorney General, had no objection to this request.

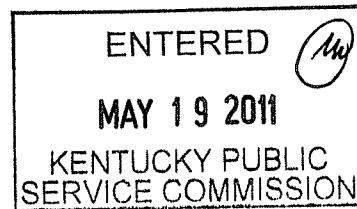
Based on a review of the Joint Applicants' unopposed motion to modify the procedural schedule, the Commission finds good cause to grant the motion.

IT IS THEREFORE ORDERED that:



The procedural schedule appended to the Commission's April 21, 2011 Order is modified to the limited extent that supplemental data requests to the Joint Applicants shall be filed no later than May 24, 2011, and the Joint Applicants' responses to supplemental data requests shall be filed no later than June 2, 2011.

2. All other provisions of the April 21, 2011 procedural schedule shall remain in full force and effect.
