**Notice of Settlement**  
**and Request for Dismissal**

On March 29, 2011, Level 3 Communications, LLC ("Level 3") filed revised tariff sheets for its Switched Access Services Tariff to revise, among other things, the definition of "End Office." These revisions became effective April 28, 2011. On April 26, 2011, AT&T Communications of the South Central States, LLC, BellSouth Long Distance, Inc. d/b/a AT&T Long Distance Service, BellSouth Telecommunications, Inc. d/b/a AT&T Kentucky, and TCG Ohio (collectively, "AT&T") filed a motion for leave to intervene, to suspend, and to investigate the March 29, 2011 tariff filing. Level 3 and AT&T have reached an agreement to resolve AT&T's concerns about and objection to the revised definition of "End Office" in Level 3's Kentucky P.S.C. Tariff No. 3 Third Revised Page 6, as follows:

- Level 3 will file a revised tariff sheet restoring the prior definition of "End Office" by August 29, 2011;
- After review and acceptance of Level 3's tariff revision by AT&T, AT&T will file with the Commission a notice of withdrawal of its objection to Level 3's revised tariff, and consent to the revised tariff with the prior definition of "End Office" becoming effective upon filing.

WHEREFORE, Level 3 and AT&T jointly request that the Commission enter an order directing Level 3 to file a revised tariff sheet containing the prior definition of "End Office" by August 29, 2011, and upon the filing of AT&T's notice of withdrawal to close and remove this case from the Commission's docket.
