Dear Tip:

This letter is to confirm and memorialize the agreement by our respective clients to amend, clarify, and supplement the Settlement Agreement by adding a new subparagraph 2(e). Specifically, and in consideration of the mutual promises and representations set forth below, the Parties to the Settlement Agreement (as defined therein), mutually acknowledge and agree as follows:

e. Transition –

Notwithstanding anything to the contrary in section 2(b) of the parties' settlement agreement, the parties agree that upon Kentucky PSC approval of the settlement agreement, they will work expeditiously to transition intraLATA toll customers as described therein. AT&T and South Central acknowledge, however, that, pursuant to section 2(b), South Central already has notified its end-user subscribers that as of December 30, 2014 (or such later date as permitted by the FCC), customers will transition to South Central intraLATA toll service (unless the customer requests another carrier), such that for traffic occurring after the transition date permitted by the FCC, South Central will be responsible for billing



its end-users, and pursuant to section 1 of the settlement agreement, South Central will bill AT&T only the access charges associated with AT&T traffic.
