RE: Conference Call of November 18, 2013

On November 18, 2013, Commission Staff conducted a conference call in this matter to discuss the current status of negotiations between the parties. Participating in the conference call were:

Robert C. Moore	-	Forest Creek LLC
Bruce Smith	-	Jessamine-South Elkhorn Water District
Gerald Wuetcher	-	Commission Staff

The conference call was originally scheduled for November 14, 2013. Due to scheduling problems, however, the parties and Commission Staff agreed to reschedule the call.

Beginning the conference call, Mr. Wuetcher also stated that Commission Staff would prepare minutes of the conference for the case record, that a copy of the minutes would be provided to all parties, and that all parties would be given an opportunity to submit written comments upon those minutes.

Mr. Moore and Mr. Smith then discussed the status of negotiations between the parties. Mr. Moore indicated that an agreement in general had been reached and a written document had been produced. Mr. Smith stated that Jessamine-South Elkhorn Water District had executed the agreement and forwarded to Forest Creek LLC. Mr. Moore indicated that Forest Creek LLC had received the written agreement, was reviewing it, and expected to execute it within the next 30 days. Upon Forest Creek LLC's execution of the agreement, the agreement would be filed with the Commission.

Mr. Moore and Mr. Smith agreed that a conference call should be scheduled for December 16, 2013 to discuss the status of the case. They further agreed that the call should not be held if a settlement agreement has been filed by that date.

The conference then adjourned.
