

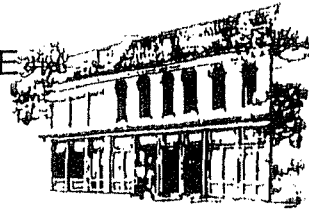

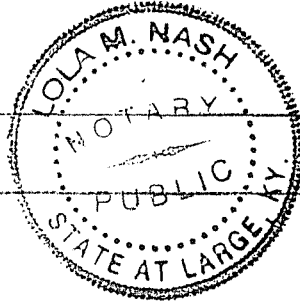

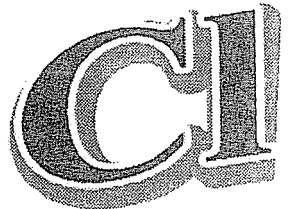

Bluegrass Gas Sales Notice to Customers Gas Rate Adjustment- Pursuant to the regulations of the Public Service Commission(Commission), Bluegrass Gas Sales, Inc. (BGS) gives notice that it intends to increase its gas rates. The rates listed below, which are approximately a 24.35% average increase over the current rates, are to be effective October 1, 2011, or sooner if approved by the Commission. The average customer bill will increase from ~\$71.26 per month to \$88.61 per month. Further information may be obtained from the Commission or BGS. The Public Service Commission may order rates to be charged that differ from these proposed rates. Such action may result in rates for consumers other than the rates in this notice, which may be higher or lower than those proposed by BGS. Any corporation, association, body politic or person may by timely motion, within 30 days of this Notice, request intervention in this case. Intervention beyond the 30 day period may be granted for good cause shown. The Motion must be submitted to the the Public Service Commission, 211 Sower Blvd., Box 615, Frankfort, Ky 40602 and should state the grounds for the request, including the interest and status of the party.
