


Dear Jimmy,

We have been notified by one of our suppliers, Cannonsburg Water District, that they are increasing our water rates by .28 cents per thousand gallons. We will be passing this increase to our customers. Based on our contract for your water use, we will be increasing the per thousand cost from \$1.78 to \$1.83 beginning with December 1, 2011 billing. The base amount of \$545.75 will remain same. We are submitting this notice simultaneously to the Kentucky Public Service Commission.
