ORDER TO SATISFY OR ANSWER



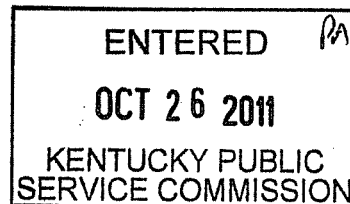

AME Church vs. Utilities Inc. aka Water Services Inc of Kentucky

Met with Brother James Bolen [REDACTED] (cell) and [REDACTED] home and Cindy Sphrag, secretary/treasurer of the church about a water bill from Utilities Inc. that was over \$1,018.

Brother James Thomas opened the bill – spoke with Bro. Bolen who said it could not be right.

James Thomas went to city hall and was directed to Mike Pickard of the water company. Pickard said meter had been reread and it was higher than the bill.

The church paid the bill. Three women from the church went to the city council meeting and were told that there was nothing the city could do. Mike Pickard, present at the meeting, denied that he told Bro. Thomas to pay the bill before any adjustments could be made. He said that Bro. Thomas was so hard of hearing that he had trouble communicating.

Richard Frizzell, a plumber, checked the church on February 3rd and found no leaks at all. He is willing to file an affidavit to that effect.

At 11:00 a.m. I called PSC complaint line to get the forms to file a formal complaint. I spoke with Rosemary (?) and she took the information.

She called back at 11:30 and said that the meter had not been checked by Mike Pickard because no one had contacted him. (This contradicts what the church members said about Mike telling Bro. Thomas that he had “re-read” the meter).

Before the complaint could be considered, Mr. Pickard would have to check the meter. She gave me Mike Pickard’s cell phone number [REDACTED]

I immediately called Brother James Bolen and asked him to contact Mike regarding checking the meter. Bro James asked if this was the same guy who wanted to charge \$20 to dig up the meter and check it. I didn’t know.

Alternatives:

1. Wait for PSC to find no reason for complaint and refile a formal complaint asking for a hearing
2. Wait for rejection and then sue them in the Kentucky court.

March 9, 2010

Got a call from Rosemary at the PSC – 1-800-772-4636, ext. 406 asking if the issues the church raised had been dealt with. I told her probably not – but offered to check with Rev. Bolen to get the latest.

Called Rev. Bolen – he said that Mike Pickard had come out and told him that if he disconnected the meter and ran a gallon of water through the system it would show a gallon of water when he stopped it.

Huh?

Anyway, James said another bill arrived for \$23. Whatever it was hasn't reoccurred.

Will call PSC tomorrow and let them know.


Reverend James Bolen of Clinton AME Church asked me to check with your office on the progress of their issue with Utilities, Inc. concerning a bill for \$1018.19 received by the Church. (See attached). It appears there has been no progress.

There has been phone communication with your office. Reverend Bolen is unclear what else the Church needs to do to formalize a complaint against this company. The Church was instructed to have a representative of the Company re-read its meter. That has been done. Since the November bill, the charge has returned to its former level. No work was performed by the Church or its members to change the situation as it existed when the November bill, dated December 7th arrived at the Church.

It is the contention of the Church that they did not use an average of 2,967 gallons of water a day during the month of November 2009. It is their belief that the meter was either misread, miscalculated or both. It is their contention that the error exists on the part of the Company, for which the Church should be refunded the overpayment.

Please send the necessary paperwork to this office so I may assist church leaders in requesting a formal telephonic hearing on the issue of the November bill.
