- Pursuant to KRS 74.115(1), letters were sent by Meade County residents or "Freeholders" to Jim Bruce, HCWD 1 General Manager, requesting the Board of Commissioners of HCWD 1 petition the Meade County Judge/Executive for purposes of incorporating into the HCWD 1 that portion of the Fort Knox Military Installation which is located in Meade County, Kentucky.

- Petition of Hardin County Water District No. 1 (HCWD 1) to Enlarge its Territorial Limits was sent to Bullitt County Judge/Executive Melanie Roberts on February 22, 2012 for review; and
- A Legal Notice requesting the expansion of HCWD 1 to include that portion of the Fort Knox Military Installation which lies within Bullitt County, Kentucky was published in *The Pioneer News* newspaper, Shepherdsville, KY, on February 27, 2012; and
- Pursuant to KRS 74.115(1), letters were sent by Bullitt County residents or "Freeholders" to Jim Bruce, HCWD 1 General Manager, requesting the Board of Commissioners of HCWD 1 petition the Bullitt County Judge/Executive for purposes of incorporating into the HCWD 1 that portion of the Fort Knox Military Installation which is located in Bullitt County, Kentucky.
