ORDER

On October 31, 2011, Coolbrook Utilities, LLC ("Coolbrook") filed its application for an adjustment of its rates for sewer service and further notified the Commission of its intent to place its proposed rates into effect on December 1, 2011. Finding that further proceedings are necessary to determine the reasonableness of the proposed rates and that these proceedings cannot be completed prior to the effective date of the proposed rates, the Commission HEREBY ORDERS that:

1. This proceeding is established to investigate the reasonableness of Coolbrook's proposed rates.
2. Coolbrook's proposed rates are suspended for a period of five months, from December 1, 2011 through April 30, 2012.
3. No later than February 1, 2012, Commission Staff shall file with the Commission and serve upon all parties of record a report containing its findings and recommendations on Coolbrook's application.
4. The parties shall file with the Commission their written comments on and any objections to the findings and recommendations contained in the Commission Staff Report no later than February 15, 2012, or 14 days after the date of the filing of the

Commission Staff Report, whichever occurs earlier. Any party may file with such submission any additional evidence for the Commission's consideration.

5. A party's failure to file written objections to a finding or recommendation contained in the Staff Report by February 15, 2012, or 14 days after the date of the filing of the Commission Staff Report, whichever occurs earlier, shall be deemed as agreement with that finding or recommendation.

6. No later than February 15, 2012, or 14 days after the date of the filing of the Commission Staff Report, whichever occurs earlier, each party shall notify the Commission in writing whether this matter may be submitted for decision based upon the existing record and without hearing.

7. An informal conference shall be held in this matter on February 29, 2012 at 10:00 a.m., Eastern Standard Time, at the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.

8. A formal hearing shall be held in this matter at a date and time that the Commission will designate in a subsequent Order.

9. Each party shall file with the Commission, no later than March 09, 2012, a list of the persons it intends to call as witnesses at the scheduled hearing and a summary of each witness's expected testimony.

10. Coolbrook shall publish notice of the scheduled hearing in accordance with 807 KAR 5:076, Section 11.


11. Pursuant to KRS 278.360, the record of the formal hearing in this matter shall be by videotape.
