The West Laurel Water Association respectfully requests that the Commission allow for an adjustment to our rates in accordance with 807 KAR 5:068 Purchased Water Adjustment clause.

The Association has been notified by its supplier, Wood Creek Water District that its wholesale rate is increasing from \$2.32 to \$2.92 per 1000 gallons. This increase has an effective date of November 18, 2011.
