ORDER

On September 4, 2014, the Community Action Council for Lexington-Fayette, Bourbon, Harrison, and Nicholas Counties, Inc. ("CAC") filed a motion requesting permission to allow Malcolm R. Ratchford, Executive Director of CAC, to adopt, with certain revisions, the January 28, 2013 pre-filed written direct testimony of Charles D. Lanter. In support of its motion, CAC states that Mr. Lanter is no longer employed by CAC and has taken a position with Lexington-Fayette Urban County Government. Attached to the motion is Mr. Ratchford's affidavit which, among other things, revises Mr. Lanter's testimony to include Mr. Ratchford's current position and professional background as well as CAC's current position on prepay metering and remote disconnects as reflected in the June 30, 2014 Report of Joint Utilities.

Having reviewed the motion and being otherwise sufficiently advised, the Commission finds that CAC has established good cause to permit Mr. Ratchford to adopt the pre-filed testimony of Mr. Lanter.

IT IS THEREFORE ORDERED that CAC's motion to allow Mr. Ratchford to adopt and revise the testimony of Mr. Lanter is hereby granted.
