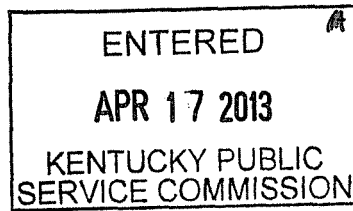
ORDER

On April 10, 2013, Joe Childers, an attorney licensed to practice law in the Commonwealth of Kentucky, who is representing Alexander DeSha, Tom Vierheller, Beverly May, and the Sierra Club, moved the Commission to admit *pro hac vice* Shannon W. Fisk, an attorney whose office is 1617 John F.
