SUBJECT: Informal Conference, January 17, 2012

Pursuant to Staff notice, an informal conference ("IC") was held on January 17, 2012. A copy of the conference attendance list is attached. The conference was scheduled for the purpose of discussing issues relating to the request of Kentucky Utilities Company ("KU") and Louisville Gas and Electric Company ("LG&E") to continue their Real-Time Pricing ("RTP") Riders.

The conference began with a discussion of the manner in which KU and LG&E promoted the pilot RTP to prospective customers. Brochures describing the RTP program were prepared and mailed to all major account customers. Those expressing an interest were contacted individually by a KU or LG&E employee. KU and LG&E indicated that few customers respond to curtailable or interruptible tariffs because of the lack of savings and the risk involved. Further discussion related to KU's and LG&E's plans to continue the pilot until the next rate case at which time they will either request to continue or cancel the RTP Riders.

The IC was then adjourned.
