O R D E R

On May 29, 2012, Harry Thompson, Chattaco, Inc., and Wilon Gathering Systems, Inc. ("Respondents") filed a motion requesting a 14-day extension of time to file responses to the Commission Staff's initial request for information. Respondents state that they intend to provide appropriate responses within a reasonable time and submit that a 14-day extension is reasonable. They also request permission to take discovery from the Complainant, Kentucky Frontier Gas Company, LLC ("Frontier") and state that discovery is necessary to prove the defenses to the Complaint and to establish evidence in support of their Counter-Complaint that has been filed with the Commission.

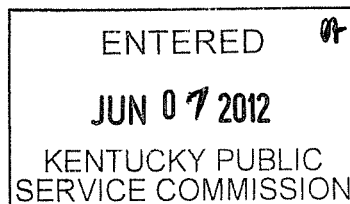

motion, finds that Frontier should likewise be granted permission to take discovery from the Respondents.


IT IS THEREFORE ORDERED that:
