

MOTION TO INTERVENE OF KENERGY CORP.

Comes **KENERGY CORP.** (“Kenergy”), by counsel, and moves the Commission for entry of order allowing it full intervention in this proceeding pursuant to 807 KAR 5:001 §3(8). In support of this motion, Kenergy states:

1. Kenergy is a rural electric cooperative corporation organized pursuant to KRS Chapter 279. Kenergy's mailing address is Post Office Box 18, Henderson, Kentucky 42419-0018. Kenergy is a retail electric supplier as defined under KRS

278.010(4) and is one of the three (3) member-owners of Big Rivers Electric Corporation (“Big Rivers”).

2. Kenergy is a member-owner of Big Rivers and a distributor of energy produced by Big Rivers has an interest in ensuring that the allocation of the costs of environmental compliance plan are allocated fairly among the different classes of rate payers. Granting full intervention to Kenergy will not unduly complicate or disrupt this proceeding. Kenergy agrees to be bound by the current schedule of record in this matter.




