O R D E R

By Order issued June 29, 2012, the Commission approved Duke Energy Kentucky, Inc.'s ("Duke Kentucky") request to expand its existing Demand-Side Management ("DSM") portfolio and to recover through its DSM Rate Rider the cost of all approved DSM measures and programs, lost revenues, and shared savings. Appended to that Order was a schedule of new residential and non-residential DSM surcharge rates to be charged to electric and gas customers.

The Commission, on its own motion, hereby finds that the Appendix to the June 29, 2012 Order included the incorrect existing DSM surcharge rate for non-residential distribution customers, did not include the total non-residential DSM surcharge rate, and did not clearly label the approved DSM Surcharge rates to be charged in the future. Accordingly, the June 29, 2012 Order should be amended, *nunc pro tunc*, to the limited extent that the Appendix thereto is corrected to clearly reflect only the approved DSM surcharge rates.

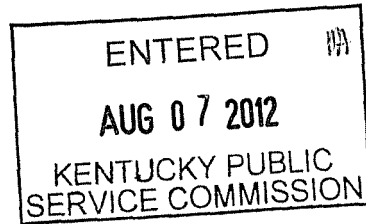
IT IS THEREFORE ORDERED, *nunc pro tunc*, that:

2. All other provisions of the June 29, 2012 Order shall remain in full force and effect.
