



PEAKS MILL WATER DISTRICT has filed an application with the Public Service commission for a proposed rate change for water service. The change is made necessary due to an increase in the wholesale price of water from our supplier. The rates contained in this notice are the rates proposed by Peaks Mill Water District. However, the Public Service Commission may order rates to be charged that differ from these proposed rates. Such action may result in rates for consumers other than the rates in this notice.

WHEREAS, the Frankfort Electric and Water Plant Board has raised the wholesale cost of water and

WHEREAS, the Public Service Commission has approved the rate increase; and

WHEREAS, the District desires to adjust its rates to its customers to reflect the wholesale rate increase.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Peaks Mill Water District as follows:


SECTION 1. That the District hereby accepts the rate awarded by the Public Service Commission and approves the raising of rates by a like amount to its customers..



After March 31, 2014, FPB will continue to charge \$2.01 per 1,000 gallons until it files a revised tariff that is approved by the Commission.

NOTE: As of April 1, 2011, this tariff sheet cancels and replaces all other tariff sheets on file containing general rates applicable to wholesale water districts and implements the general rates established in Case No. 2010-00485. FPB's tariff sheet containing charges for the Ky. River Authority withdrawal fee on file with the Commission shall remain in full force and effect.
