SUBJECT: November 29, 2012 Informal Conference

An Informal Conference (“IC”) was held in this case on November 29, 2012 at the Commission’s offices. Attending the IC for Johnson County Gas Company (“Johnson County”) were Joe Childers, Bud Rife, and Renae Tackett. Commission Staff (“Staff”) attending the IC were Jeff Shaw, Leah Faulkner, Gary Glover and Allyson Honaker. Johnson County had requested the IC in order to discuss issues related to the Staff’s second data request to Johnson County and the status of billings for Johnson County’s wholesale gas purchases.

Johnson County sought and received clarification from Staff on items contained in Staff’s second data request. Johnson County and Staff also discussed how Johnson County would seek recovery of the \$195,000 amount related to its recently approved bankruptcy plan.

Johnson County also discussed with Staff the calculation of its Gas Cost Adjustment (“GCA”) application with regard to past and future billed amounts from one of its gas suppliers, Hall, Stephens, & Hall. Staff offered to send Johnson County a spread sheet containing factual summary information that could be used for its GCA filing due to be filed December 1, 2012 for rates effective January 1, 2013.

There being no further issues to discuss, the conference was adjourned.
