COMMISSION STAFF'S SECOND REQUEST FOR INFORMATION TO
MEADE COUNTY RURAL ELECTRIC COOPERATIVE CORPORATION

Meade County Rural Electric Cooperative Corporation ("Meade") pursuant to 807 KAR 5:001, is to file with the Commission the original and six copies of the following information, with a copy to all parties of record. The information requested herein is due within 10 days of the date of this request. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, be accompanied by a signed certification of the preparer or the person supervising the preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Meade shall make timely amendment to any prior response if they obtain information which indicates that the response was incorrect when made or, though


correct when made, is now incorrect in any material respect. For any request to which Meade fails or refuses to furnish all or part of the requested information, they shall provide a written explanation of the specific grounds for their failure to completely and precisely respond. Careful attention shall be given to copied material to ensure that it is legible.

1. Refer to the response to Item 1 of Commission Staff's First Information Request.

a. Refer to Item 1.a. Provide an updated proposed Schedule 26 to reflect that Meade will purchase the CFL lamps and invoice Big Rivers Electric Corporation ("Big Rivers") for reimbursement.

b. Refer to Item 1.b. The response indicates that, for each of the referenced schedules, Meade will submit an invoice to Big Rivers for reimbursement. If that is correct, provide updated proposed tariff pages for Schedules 27 through 34 reflecting the necessary language change. If that is not correct, explain what is meant by the response.

2. Refer to the additional tariff filed by Meade on April 30, 2012, proposed Schedule 35, Residential Weatherization Program-Primary Heating Source Non-Electric. Schedule 35 includes language requiring that Meade must receive the corresponding incentive payment from Big Rivers before paying the incentive to its customer. Is Meade required to invoice Big Rivers prior to receiving the incentive payment for this program? If yes, provide an updated tariff for Schedule 35 reflecting the necessary language change.
