
Dear Mr. Derouen:

Please be advised that representatives of the Meade County RECC (Meade) met with representatives of Hilltop Big Bend Quarry, LLC, (Hilltop) on Friday, August 3, 2012 at Meade's office in Brandenburg, Kentucky.
