The "total refunded debt service" chart (Exhibit D) refers to the Series 1991 Bonds (closed on 6/20/1990) and the correct name of that series of bonds should be "Bonds of 1989, Series B".

The total principal amount of the KRWFC loan should be \$6,311,000, not the stated \$6,310,000.

Dear Mr. Jones:

Commission Staff is completing its review of Mountain District's Application for authorization to enter a loan with KRWA in the amount of \$6,310,000. It has found a discrepancy in the application and requests clarification. In the application, Mountain District refers to Mountain Water District Waterworks Revenue Bonds of 1989 Series B, but not to any 1991 Series. Exhibit D of the Application contains a "Total Refunded Debt Service" Chart for a Series 1991, but not to a 1989 Series B. To what bond series does the "Total Refunded Debt Service" Chart for a Series 1991 actually refer?

Any assistance would be greatly appreciated.
