

Air Liquide Large Industries U.S. LP v. Kentucky Power Company

Pursuant to an Order dated September 6, 2102, an informal conference was held at the Commission's offices on September 21, 2012. A list of the attendees is attached hereto.

The purpose of the conference was to discuss the establishment of a procedural schedule and the narrowing of issues. After a brief discussion, the parties acknowledged the central issue to this matter involves a legal question as to what constitutes a "customer" as that term is used in Kentucky Power's existing Tariff RTP. The parties further agreed to file simultaneous briefs on this legal issue by October 22, 2012, with Air Liquide not objecting to Kentucky Power's inclusion of affidavit(s) in support of the company's legal memorandum.

There being no further discussions, the informal conference was adjourned.
