An informal conference was held in this matter on Thursday, November 8, 2012. Representatives of Mountain Rural Telephone Cooperative Corporation, Inc. ("Mountain Rural") and Commission Staff were present for this meeting. An attendance list is attached. The purpose of the conference was to discuss the incident involved in this case.

The conference was opened by Commission Staff. Mountain Rural was asked whether it had implemented any changes as a result of this incident. Representatives of Mountain Rural proceeded to describe changes that were made to its safety practices, incident notification procedures and its contractor relations. Mountain Rural had compiled a binder of information to show the steps taken since the incident. Mountain Rural will file a copy of the binder in the record of this case.

Settlement negotiations were also discussed and the meeting was adjourned.
