



Dear Mr. Derouen,

I have been notified by Mr. Gerald Wuetcher of your staff that clarification and/or additional explanation are needed relative to a filing requirement in the above-referenced rate case. I sincerely appreciate Mr. Wuetcher's assistance in this regard, and I hope this letter is sufficient to address the filing requirement.

The applicable filing requirement calls for Middletown Waste Disposal to attach "a copy of each outstanding evidence of indebtedness." In Middletown's most recent rate case decision in 2010, the Commission allowed for ratemaking purposes only the interest expense on a loan associated with the land upon which the sewage treatment plant sits, and disallowed all other interest expense. Middletown's rate request in this current case conforms with that ruling by not requesting the interest expense previously disallowed (please refer to the pro forma income statement and explanatory Note O), so I did not want to confuse this filing by adding debt documents whose interest expense had been disallowed in the prior case. I did, however, attach as Exhibit 8 the amortization schedule for the remainder of the debt which had been allowed in the prior case.

Mr. Wuetcher has suggested I should provide either a letter explaining the grounds for a deviation of the filing requirement, or reference to the previous case in which the documents were filed. As to the latter, that case number was 2009-00227, and no existing debt other than that found reasonable for ratemaking purposes in Case No. 2009-00227 has been included within the filing. As to the former, please treat this letter as a request for deviation of the requirement to file all debt documents, on the grounds that only the debt documents relevant to this proceeding are necessary, and have already been provided.

I have been notified by Mr. Gerald Wuetcher of your staff that additional clarifications and/or additional explanations beyond those in my letter dated September 19, 2012 are needed relative to a filing requirement in the above-referenced rate case. Specifically, Middletown's partners loaned the utility \$20,000 in April and May of 2012 to finance the replacement of an aging and leaky air header, but no written loan documents were prepared relative to this loan, and no evidence of indebtedness exists other than the checks written by the partners to Middletown.

I hope this clarification provides the necessary information to meet the filing requirement.
