ATTORNEY GENERAL'S FORMAL NOTICE REGARDING THE 14 DECEMBER 2012 COMMISISON STAFF REPORT

In an effort to assist the Commission's review of the Application, the Attorney General provides this formal notice regarding the 14 December 2012 Commission Staff Report. The Attorney General did not object to the Staff Report; furthermore, he does not request an informal conference or public hearing. In support of this position, the Attorney General states the following.

On 22 August 2012, Middletown Waste Disposal, Inc., filed an application for an adjustment in rates using the alternative rate adjustment procedure for small utilities (807 KAR 5:076). On 14 December 2012, the Commission Staff Report was filed into the record in this proceeding.

The Attorney General did not seek to contest the Commission Staff Report, so he did not submit written comments to the Staff Report or request an informal conference or public hearing. The Applicant, through a 21 December 2012 filing, did request the issuance of an Amended Staff Report to reflect three adjustments: the correction of an

error with regard to the billing analysis for the applicant; an update of the Staff Report for the interest expense determination; and an update to the Staff Report for the electricity expense determination.

On 15 January 2013, the Attorney General (with simultaneous notice to the Applicant) conveyed by electronic message that he had no objection to the correction of an error in the Staff Report.² He also conveyed that he had no objection to the consideration of the Applicant's submission of information or the request for a change in the electricity expense determination if consideration of the change was through the normal "known/measurable" process. With regard to the interest expense issue, the Attorney General indicated that he did not contest or object to the position of Commission Staff. This remains the position of the Attorney General.

By review of the public records of the Commission, the Attorney General is aware that the Applicant has at least one other case pending before this Commission, Case No. 2012-00526. The Attorney General is not a party to that proceeding, and he does not plan to seek intervention into that case. To the extent that a final decision in this matter has a bearing on the request for the authorization of financing sought in that application, the Attorney General does seek to obtain a decision in this case as soon as reasonable so as not to frustrate or delay Case No. 2012-00526.

Good afternoon.

On 13 December 2012, the Commission entered an Order scheduling an informal conference on 17 January 2013 (at 1:30 PM – eastern).

If the informal conference is held, then I would like to participate via a teleconference option (in that I will not be in Frankfort that day). Please provide the information for the call-in if such arrangements can be made.

With regard to this matter (if it is of assistance to the planning of the Commission and its Staff), the Attorney General did not submit written comments to the Staff Report or request an informal conference or public hearing. To this end, the AG did not place any issue into play. My understanding is that, consequent to a 27 December 2012 conference, there will be a correction with regard to the Staff position on revenue normalization. The Attorney General has no objection to a correction to the Staff Report.

With regard to the other two issues that the Applicant presents, issues regarding (1) utilities and (2) interest expense, the Attorney General notes the following.
