
Per your correspondence of October 18, 2012, please accept this as Owen Electric's supplement to its request for an informal conference. Owen is requesting the informal conference prior to filing its rate application to discuss with the PSC staff the following:

1. Proposed rate design with no change in the customer charge;
2. A purchased power adjustment clause;
3. A combined purchased power clause and fuel adjustment clause;
4. A forecasted fuel adjustment clause;
5. A roll in of the environmental surcharge at the distribution level; and,
6. Status of Owen's DSM projects.

Owen has a need for additional revenue because of East Kentucky Power Cooperative's last rate increase. In addition, the fuel clause is not working as presently designed. Owen would like to discuss all of these matters with PSC staff before filing its formal rate application.
