
Comes Owen Electric, Inc., ("OEC") by counsel and hereby moves the Public Service Commission as follows:



RULES AND REGULATIONS

28. **METER READING**

The Cooperative utilizes solid state meters and its advanced metering infrastructure (AMI) to accurately and efficiently read meters. The Cooperative shall read each member's meter each month for the purpose of determining each account's usage of electricity in calculation the monthly bill. Exceptions to the monthly reading will be allowed only for those meters which may be estimated due to technical issues that do not allow for reliable communications to the meter. Members who prohibit the Cooperative from obtaining remote meter readings by refusing the use of the Cooperative's solid state meters and AMI system will be assessed a \$30.00 manual meter reading fee per occurrence.
