RE: Conference Call of November 8, 2012

On November 8, 2012, Commission Staff held a telephone conference call in this matter to discuss a procedural schedule. Participating in the conference were:

Eddie Beavers	-	Commission Staff

Beginning the conference, Mr. Wuetcher also stated that Commission Staff would prepare minutes of the conference for the case record, that a copy of the minutes would be provided to all parties, and that all parties would be given an opportunity to submit written comments upon those minutes.

Mr. Wuetcher inquired about any time considerations to setting a procedural schedule. Mr. Jones stated that the present bids on the proposed facilities would expire on December 1, 2012. He and Mr. Smith stated that the Water District had no assurance that the winning bidder would extend the time of its bid and that any extension might adversely affect the terms of the winning bid. Mr. Jones also noted that a lengthy review period increased the Water District's financial risks as current financial conditions were uncertain and potentially volatile.

Mr. Watt responded that, given the Intervenors' complaint in Case No. 2011-00138, the Water District should have been fully aware of the possibility of a lengthy Commission review and incorporated such possibility into its planning. He stated that the Water District had the burden of proof in this matter and that discovery and a hearing were necessary to ensure the Intervenors' right to due process. He further stated that the Water District should be required to file written testimony.

Mr. Smith countered that previous Commission proceedings involving similar types of water improvement projects had been decided without any hearing and on

documentary evidence of same quantity and quality that Jessamine-South Elkhorn had provided in its application. Mr. Watt replied that in his experience before the Commission greater supporting evidence had been expected and that a hearing was standard.

Noting that agreement on a procedural schedule did not appear likely, Mr. Wuetcher suggested that the Intervenors formally move for a hearing and procedural schedule. Such motion would place the matter before the Commission and allow both parties to present their views. Mr. Watt agreed to submit his motion by November 9, 2012 and to serve a copy upon the Water District's counsel by electronic mail. Mr. Smith stated that the Water District would respond no later than November 16, 2012.

The participants discussed the incorporation of the record of Case No. 2011-00138. They agreed that the incorporation of that record might assist the Commission's review. Mr. Wuetcher stated that the Commission would inform the parties of its decision regarding incorporation of the record by Order. He further advised that participants that Commission Staff would likely issue a request for information to the Water District within a few days. He agreed to advise the parties by electronic mail as soon as the request was issued.,

The conference then adjourned.
