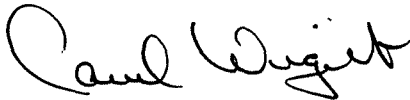

 - a. Have you experienced any problems in administering the refund of any over-recovery or collection of any under-recovery of environmental surcharge cost?

Response: No.

- b. Do you recommend any changes from the current method of refunding/collecting any over- or under-recovery of environmental surcharge costs over a six-month time period? If so, what is the time period you believe is appropriate?

Response: No. Jackson Energy prefers to continue the current six-month time period.

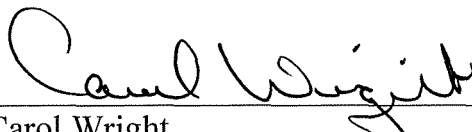
Response: Jackson Energy's actual average residential customer's kWh usage on a rolling twelve-month average is 1,108 kWh/month.

Based on this usage amount, the dollar impact any over- or under-recovery will have on the average residential customer's bill for a recovery period of six months is (\$1.26)/month and for a recovery period of twelve months is (\$.63)/month.

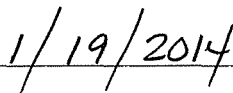
