




KENTUCKY INDUSTRIAL UTILITY CUSTOMERS, INC.'s

Kentucky Industrial Utility Customers, Inc. ("KIUC") hereby moves the Commission to establish a date-certain for KIUC-member witnesses Bill Cummings, Kelly Thomas, and Steve Henry to appear at the upcoming evidentiary hearing in the above-captioned proceeding. KIUC requests that each of these witnesses be scheduled to appear at the hearing on July 3, 2013. KIUC is not requesting a date-certain for its witness Lane Kollen.

Mr. Cummings and Ms. Thomas are out-of-town witnesses and all three KIUC witnesses would be greatly assisted for scheduling purposes by the establishment of a date-certain for their appearance at the hearing. KIUC consulted with Big Rivers Electric Corporation ("Big Rivers"), the Office of the Attorney General ("AG"), and Sierra Club regarding its request to establish a date-certain for Mr. Cummings, Ms. Thomas, and Mr. Henry. Counsel for Big Rivers and Sierra Club have indicated that they do not object to KIUC's request, as did counsel for the AG, provided that KIUC will likewise agree to accommodate the AG's own out-of-town witnesses, if necessary.
