
Having many years of knowledge and experience which impacts Kentucky Power Company's (KPC) application for a Certificate of Public Convenience and Necessity and interests that are not adequately represented by any other party to the proceeding, Lawrence County seeks full intervention to ensure that the requested CPCN is approved only if it represents the best option to satisfy low cost energy service.

American Electric Power in Lawrence County, Kentucky has been an integral part of Lawrence County and has employed hundreds of citizens throughout the surrounding areas for over fifty (50) years. The economy of Lawrence County and the surrounding area will suffer greatly as families are forced to sell their properties and move elsewhere to establish new lives and jobs. This would also disrupt the lives of their children who attend Lawrence County schools, or other schools nearby to the Big Sandy Plant. Additionally, many truck drivers who make their living hauling coal will suddenly come to an abrupt halt.

Lastly, as families are forced to move away from Lawrence County, local businesses would suffer as well, such as restaurants, grocery stores, auto shops, to name a few.

The everyday working class citizens do not appear to factor into this scenario, as it greatly impacts the economy of Lawrence County and the hard-working people who live here.

WHEREFORE, counsel for Lawrence County, Kentucky, hereby moves the Public Service Commission to grant his Petition for a re-hearing to ensure that the interests in cleaner energy and lower costs, as well as protecting the employment of numerous people are entirely represented.


