ORDER

Hardin County Water District No. 1 ("Hardin District") has moved to reschedule the hearing scheduled for January 21, 2014. In support of its motion, Hardin District states that its attorney is scheduled to be out of state beginning on January 16, 2014, and returning on January 21, 2014.

Having considered the motion, the Commission finds that the motion should be granted.

IT IS THEREFORE ORDERED that:

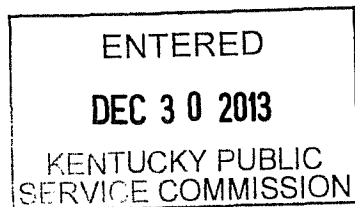
1. Hardin District's motion to reschedule the January 21, 2014 hearing is granted.
2. The hearing scheduled for January 21, 2014, in this matter is cancelled.
3. Unless all parties request that this matter be submitted for decision upon the existing record, a formal hearing in this matter shall be held on Tuesday, March 18, 2014, at 10:00 a.m. Eastern Daylight Time, in Hearing Room 1 of the Commission's offices at 211 Sower Boulevard, Frankfort, Kentucky.
4. Hardin District shall publish notice of the scheduled hearing in accordance with 807 KAR 5:001, Section 9(2)(b), no more than 21 days and no less than seven days before the day of the scheduled hearing.

5. Pursuant to KRS 278.360 and 807 KAR 5:001, Section 9(9)(a), the record of the formal hearing in this matter shall be by videotape.

6. Commission Staff shall prepare a written list of all exhibits presented at the hearing and shall file this list with the Commission with all hearing exhibits and a copy of the video transcript of the hearing.

7. Any request to cancel or postpone this hearing shall be made by motion filed with the Commission at least one week before the hearing is scheduled to commence.
