## ORDER

On April 29, 2013, Marion County Water District ("Marion") applied to adjust its rates pursuant to the purchased water adjustment procedure.<sup>1</sup>

The Commission, having reviewed the record and being sufficiently advised, finds that:

- 1. Marion purchases water from Lebanon Water Works Company ("Lebanon") and the City of Campbellsville ("Campbellsville").
- 2. On July 17, 2013, Lebanon increased its monthly meter charge to Marion from \$6.00 to \$6.75 per month and its volumetric rate from \$2.14 per 100 cubic feet to \$2.50 per 100 cubic feet.
- 3. Marion proposed a purchased water adjustment factor of 0.56 per 1,000 gallons.
  - 4. Marion proposed an effective date of July 17, 2013.
- 5. During the 12 months ended March 31, 2013, Marion purchased 460,384,650 gallons of water from Lebanon, 3,851,800 gallons of water from

Campbellsville, and sold 393,027,660 gallons of water. As a result of the increase in Lebanon's wholesale rate, Marion's cost of purchased water will increase \$221,674.50, resulting in a purchased water adjustment factor of \$0.56 per 1,000 gallons.

6. The purchased water adjustment factor of \$0.56 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.

#### IT IS THEREFORE ORDERED that:

- 1. Marion's proposed rates are approved.
- 2. The purchased water adjustment factor of \$0.56 per 1,000 gallons is approved.
- 3. The rates in Appendix B are fair, just, and reasonable and are approved for services on or after July 17, 2013.
- 4. Within 20 days of the date of this Order, Marion shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the rates approved herein.
