ORDER

On February 19, 2014, the Commission entered an Order in this matter establishing new rates for Garrison-Quincy-Ky-O-Heights Water District. The Order contained erroneous language regarding the effective dates of the new rates.

- 1. Ordering paragraph 3 of the February 19, 2014 Order contained erroneous language indicating that the new rates were for service rendered on and after the date of the Order, up to and including February 17, 2015. The new rates are effective for service rendered on and after February 19, 2014, up to and including February 19, 2015.
- 2. Ordering paragraph 4 erroneously states that the rates set forth in Appendix B are for service rendered on and after February 18, 2015. The rates set forth in Appendix B are for water service rendered on and after February 20, 2015.
- 3. Ordering paragraph 6 indicates that notice for the Phase 2 rates should be issued no earlier than 30 days, but no later than 20 days prior to February 18, 2015. Notice of the Phase 2 rates should be issued no earlier than 30 days, but no later than 20 days prior to February 20, 2015.

- 4. Appendix A contains erroneous language indicating the new rates are effective for water service rendered on and after February 17, 2014. The new rates are effective for water service rendered on and after February 19, 2014.
- 5. Appendix B contains erroneous language indicating the rates in Appendix B are for water service rendered on and after February 18, 2015. The rates set forth in Appendix B are for water service rendered on and after February 20, 2015.
- 6. Appendix D contains erroneous language indicating the date of the order and the effective date of the rates. The correct date of the Order is February 19, 2014, and the rates in Appendix D become effective on February 20, 2015.

Therefore, the Commission finds that ordering paragraphs 3, 4, and 6 and appendices A, B, and D of the February 19, 2014 Order should be amended to reflect the correct effective dates.

IT IS THEREFORE ORDERED, *nunc pro tunc*, that:

1. Ordering paragraph 3 of the February 19, 2014 Order is stricken and is replaced with the following language:

Garrison-Quincy shall charge the rates that are set forth in Appendix A for service rendered on and after the date of this Order, up to and including February 19, 2015.

2. Ordering paragraph 4 of the February 19, 2014 Order is stricken and is replaced with the following language:

Garrison-Quincy shall charge the rates that are set forth in Appendix B for service rendered on and after February 20, 2015.

3. Ordering paragraph 6 of the February 19, 2014 Order is stricken and is replaced with the following language:

No earlier than 30 days, but no later than 20 days prior to February 20, 2015, Garrison-Quincy shall publish notice of the Phase 2 rates at least once in a newspaper of general circulation in its territory or place an insert in bills rendered to its customers. Notice shall be in the form set forth in Appendix D to this Order. Garrison-Quincy shall file with the Commission proof of publication no later than ten days after publication of the notice.

4. The paragraph in Appendix A of the February 19, 2014 Order is stricken and is replaced with the following language:

The following water rates and charges are prescribed for the customers in the area served by Garrison-Quincy-Ky-O-Heights Water District for water service rendered on and after February 19, 2014. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of the Commission prior to the effect date of this Order.

5. The paragraph in Appendix B of the February 19, 2014 Order is stricken and is replaced with the following language:

The following water rates and charges are prescribed for the customers in the area served by Garrison-Quincy-Ky-O-Heights Water District for water service rendered on and after February 20, 2015.

6. The paragraph in Appendix D of the February 19, 2014 Order is stricken and is replaced with the following language:

Pursuant to the Order of February 19, 2014, of the Kentucky Public Service Commission in Case No. 2013-00350, the following rates shall become effective on February 20, 2015, for water service that Garrison-Quincy-Ky-O-Heights Water District provides.

7. All provisions of the February 19, 2014 Order that are not in conflict with the terms of this Order shall remain in effect.
