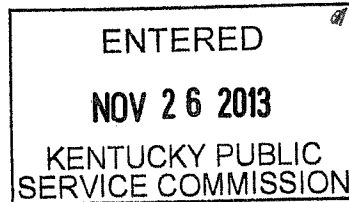

The following rates and charges are prescribed for the customers in the area served by Sandy Hook Water District for service rendered on and after November 14, 2013. All other rates and charges not specifically mentioned herein shall remain the same as those in effect under authority of the Commission prior to the effective date of this Order.

#### 5/8-inch x 3/4-inch meter

First	2,000 gallons	\$24.00 minimum bill
Next	8,000 gallons	9.40 per 1,000 gallons
Next	40,000 gallons	8.40 per 1,000 gallons
Over	50,000 gallons	7.40 per 1,000 gallons

#### 1-inch meter

First	5,000 gallons	\$52.20 minimum bill
Next	5,000 gallons	9.40 per 1,000 gallons
Next	40,000 gallons	8.40 per 1,000 gallons
Over	50,000 gallons	7.40 per 1,000 gallons

#### 1 1/2-inch meter

First	10,000 gallons	\$99.20 minimum bill
Next	40,000 gallons	8.40 per 1,000 gallons
Over	50,000 gallons	7.40 per 1,000 gallons

#### 2-inch meter

First	20,000 gallons	\$183.20 minimum bill
Next	30,000 gallons	8.40 per 1,000 gallons
Over	50,000 gallons	7.40 per 1,000 gallons

First	30,000 gallons	\$267.20 minimum bill
Next	20,000 gallons	8.40 per 1,000 gallons
