Subject: Case 2013-00008

This letter is to request an extension to reply to the PSC's request for my personal information on the subject complaint. As I have not received some of the information I required to answer all of the PSC questions I am requesting an extension until Wednesday March 26, 2013, to reply.

In the meantime I would like to make some comments and observations on LG&E response dated 2/15/13 and filed 3/1/13. On question #1, I have some comments but will not provide at this time. On question No.1.a Exhibit A pages 2 and 3 they have provided a lot of "numbers" but they provide no clarification of the situation. At least put them in the same format as on the monthly billing i.e. "by year," "average temperature," "number of days billed" and "electric/KWH/day." Same comments on Exhibit B. On question No. 1. Exhibit C, pages 2 thru 5, do these pages provide any clarification of the problem? Question No. 1.a Exhibit E, pages 3 thru 7 more numbers with addition of meter reading. Graph on page 5, what are we looking at of any significance? Exhibit E page 7 filler page? Page 8 of 8 no title, but it is partially recognizable. Exhibit F pages 1 and 2, more data, do these pages clarify any of the problem? I see the usage of KWH from 3/12/2006 through 12/12/2012, however I was informed in June 2012 by a Ms. Julie Stethen that LG&E did not have my info any further back than 5/2009! Exhibit F pages 3 thru 21, more filler.

Question No. 3, very long period, 31 years, between tests of meter, when I have paid LG&E several hundred dollars to check the meter between June 2001 and January 2012.

Question No. 4, as noted above I requested billing information for prior period back to 2001, but was advised the information was not available further back than May 2009.

Question No. 6 refer back to the meter test of June 18, 2012 by the PSC. Meter No. 384-880 (Ser#53-906-862) the meter tested within the margin of error per the report. The report stated that "one or more of the meter registration dials did not appear to be properly aligned for the correct recording of usage." And there was a mention that the seal was broken. Because of this I would like to see another type of test performed on the meter. A long term seven (7) to eight (8) weeks in actual usage of three (3) meters set-up in a parallel usage test. One, the subject meter, a new analog meter that is verified correct, and a digital meter. All set up to measure concurrent power usage. The current usage should simulate daily usage of the four (4) seasons, winter, spring, summer and fall. The amount of power used should be similar to home owner usage in normal day to day living, running a short test in a lab does not duplicate normal usage. The meter KWH usage should be monitored and recorded every other day. With regard to the meter seal being broken, why didn't the meter reader notice this situation and report it to his superiors? Or was it broken the day that Mr. Robert Lucas removed the meter for testing on January 30, 2012?

I would like an answer from LG&E on the following questions.

- 1) How many customers does LG&E provide electric power for in Jefferson County, Ky?
- 2) How many customers does LG&E /KU provide power to in the state of Kentucky?
- 3) Provide "Basic Meter Charge" by year from June 2001, through February 2013 on an annual basis.
- 4) On an annual basis year by year what is the percentage of rate increases, including all the surcharges, i.e. 1) electric fuel adjustment, 2) electric DSM, 3) environmental charge, 4) home energy assistance fund?
- 5) I understand from some of my friends who live in Indiana that Duke Power uses digital meters. Are they more accurate, if so, why doesn't LGE/KU use them in Ky?
- 6) In September, 2004 my daily usage of power jumped a significant amount. Is this an indication of when the meter became defective?

- 7) Do you know of any other instances of needle malfunctions of these analog meters?
Loose needles?
- 8) Does the malfunction of the needle move CW or CCW?
- 9) Has LG&E recorded my phone calls with LG&E employees? If so I want a copy for my use.

Due to the nature of this situation, I am requesting all my information be held in a confidential manner.
