ORDER

On January 14, 2013, North Logan Water District (“North Logan”) applied for approval to adjust its rates pursuant to the purchased water adjustment procedure.¹

The Commission, having reviewed the record and being sufficiently advised, finds that:

1. North Logan purchases water from Logan/Todd Regional Water Commission (“Logan/Todd”).

2. Logan/Todd notified North Logan that, effective March 1, 2013, its volumetric wholesale rate to North Logan would increase from \$3.75 per 1,000 gallons to \$3.83 per 1,000 gallons.

3. North Logan proposed a purchased water adjustment factor of \$0.10 per 1,000 gallons.

4. During the 12 months ended December 31, 2012, North Logan purchased 53,998,000 gallons of water from Logan/Todd. North Logan sold 44,124,000 gallons of water during the same 12 months. The increase in the cost of purchased water is \$4,319.84 resulting in a purchased water adjustment factor of \$0.10 per 1,000 gallons.

5. North Logan proposes to increase the water rates to its customers effective March 1, 2013.

6. The purchased water adjustment factor of \$0.10 per 1,000 gallons, as calculated in Appendix A to this Order, is fair, just, and reasonable and should be approved.

7. The rates set forth in Appendix B reflect the application of the proposed purchased water adjustment factor and are fair, just, and reasonable.

IT IS THEREFORE ORDERED that:

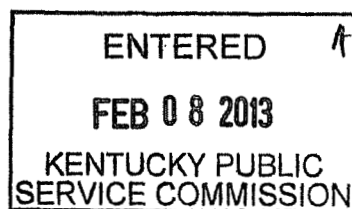
1. North Logan's proposed rates are approved.

2. The purchased water adjustment factor of \$0.10 per 1,000 gallons is approved.


3. The rates in Appendix B are fair, just, and reasonable and are approved for service rendered on or after March 1, 2013.

4. Within 20 days of the date of this Order, North Logan shall file with the Commission, using the Commission's electronic Tariff Filing System, revised tariff sheets showing the approved rates.
