MOTION TO EXTEND TIME

Comes now Complainant, SE Acquisitions, LLC, d/b/a Lightyear Network Solutions of Kentucky (“SE Acquisitions”), by counsel, and requests a thirty-day extension of time for the Defendant, YMax Communications Corporation (“YMax”) to respond to the Commission’s Order dated March 1, 2013, as follows:


1. The Commission issued an Order on or about March 1, 2013 (“Order”), rejecting YMax’s response to the Formal Complaint in this case, requiring that YMax file a further answer within ten days, and requiring that YMax engage counsel to represent it in this proceeding..

2. SE Acquisitions and YMax have, over the course of the past week, engaged in settlement discussions. The issues between the parties have not been resolved; however, there have been substantial communications.

3. SE Acquisitions believes that the likelihood of a negotiated resolution of the issues in this case will be increased if YMax is granted a thirty-day extension of time to respond to the Commission’s Order.

For the foregoing reasons, SE Acquisitions respectfully requests that YMax be granted a thirty-day extension of time to respond as directed in the Commission's Order, such that its answer to the Formal Complaint shall be due on or before April 9, 2013.
