ORDER

On June 24, 2013, Hardin County Water District No. 1 ("Hardin District") applied for an adjustment of its rates for sewer service. Having reviewed the record, and being otherwise sufficiently advised, the Commission finds that:

1. Hardin District is a water and sewer district organized under the provisions of KRS Chapter 74¹ and is a political subdivision of the Commonwealth of Kentucky.²
2. Hardin District began sewer utility operations on July 1, 2005.³
3. Hardin District owns, operates, and manages facilities that are used for and in connection with the treatment of sewage for 8,940 customers in Hardin and Meade Counties, Kentucky.⁴
4. For the calendar year ending December 31, 2012, Hardin District reported revenues of \$6,256,677 and total operating expenses of \$6,080,698 for its sewer operations.⁵

5. For the calendar year ending December 31, 2012, Hardin District reported net operating income of \$436,482 for its sewer operations.⁶

6. For the calendar year ending December 31, 2012, Hardin District reported net utility plant related to the provision of sewage services of \$41,713,647.⁷

7. For the calendar year ending December 31, 2012, Hardin District reported total assets of \$48,164,923.⁸

8. For the calendar year ending December 31, 2012, Hardin District reported total long-term debt of \$1,562,065, total current and accrued liabilities of \$1,274,931, and total equity capital of (\$169,811).⁹

9. In view of Hardin District's financial assets and its status as a political subdivision of the Commonwealth of Kentucky, Hardin District has sufficient financial integrity to ensure the continuity of sewage service. A copy of a valid third-party beneficiary agreement guaranteeing the continued operation of the sewage treatment facilities is not required to proceed with its application for a sewage treatment rate adjustment.¹⁰

IT IS THEREFORE ORDERED that Hardin District is not required to file a valid third-party beneficiary agreement guaranteeing the continued operation of its sewage treatment facilities and may proceed with the application to adjust its rate for sewer services.


