**TAYLOR COUNTY RURAL ELECTRIC COOPERATIVE CORPORATION'S
SECOND MOTION TO STRIKE DOCUMENT**

Defendant, Taylor County Rural Electric Cooperative Corporation ("Taylor County"), by counsel, moves the Commission to strike from this record an untitled document apparently intended as Complainant's response to Taylor County's previous Motion to Dismiss, that untitled document having been received by the Commission on August 5, 2013. In support of this additional Motion to Strike, Taylor County advises the Commission of the following:


1. The document bearing Complainant's signature which was received by the Commission on August 5, 2013, is, once again, presented in a form which is, in multiple respects, violative of this Commission's Rules of procedure.

2. Assuming the subject document to be an intended response to Taylor County's Motion to Dismiss filed herein on July 26, 2013, such response was not timely filed under the Commission's Rules of procedure, and was not accompanied by any Motion for extension or enlargement of the required filing deadline.

3. Once again, Complainant has failed / refused to provide for service upon Taylor County's counsel of a copy of the subject document, and does not purport to have done so

inasmuch as that document does not include the required certificate of service. Taylor County's counsel, by now having been apprised that Complainant will continue to thumb his nose at this Commission's Rules of procedure, is left to periodically examine the Commission's website in order to determine whether Complainant has purported to file documents, timely or otherwise, as a part of this proceeding.


