**FARMERS RURAL ELECTRIC COOPERATIVE'S
MOTION FOR EXTENSION OF TIME TO RESPOND TO
COMMISSION STAFF'S DATA REQUEST**

Comes now Farmers Rural Electric Cooperative Corporation ("FRECC"), by and through counsel, and moves the Kentucky Public Service Commission ("Commission") for an Order granting a Motion for Extension of Time to Respond to the Commission Staff's Data Request.

In support of this Motion, FRECC states that on June 18, 2013, the Commission Staff's Data Request to FRECC was issued requesting to file its Answers to same within 14 days from June 8, 2013. FRECC's Answers to these Data Requests are therefore due to be filed on or before July 2, 2013. FRECC has been working to provide the Answers to these Data Requests but will be unable to file same until Tuesday July 16, 2013, due to the number and technical nature of

the questions. Accordingly, FRECC requests an extension of time of 14 days from July 2, 2013, within which to respond to the Commission Staff's Data Request.

WHEREFORE, FRECC respectfully request that the Commission enter an Order approving a Motion for Extension of Time to Respond to Commission Staff's Data Request and permit the filing of the prepared Answers currently due July 2, 2013 to be filed no later July 16, 2013.
